4. Carol Sohn - President's Report

- Planning for 2025 WSWGGA tournament started 5½ years ago. Meadow Springs has 2 tournament co-chairs and 8 committee chairs to manage the event. Details will be gathered in book in approximately 1 month to pass on to Seattle, the 2026 tournament host.
- Carol asked about a press release concerning the 2025 championship tournament that was done with incorrect information. No one present knew who coordinated the press release.
- Based upon the survey responses from 12 clubs, charitable contributions to help the community and promote golf totaled ~\$181,000 for 2024. Meridian Valley had most contributions at ~\$76,500.

Discussion continues regarding Canterwood Senior Championship dates which fall on a Tuesday and Wednesday (versus the typical Monday/Tuesday) and a practice round will need to be added. Suggested considering a Monday shotgun for the practice round.

WSWGA Championship tournament in 2026 at Seattle - Janet Peterson

- Theme is "Birdies in Paradise"
- Shotgun start times are planned for
  - Noon Monday with dinner in the evening,
  - Trustee Meeting on Tuesday,
  - Morning start on Wednesday with awards lunch
- There are some elevation changes. There will be motor carts for rent and push carts are available. Players can bring their own push carts, however no remote control, battery operated carts are allowed on the course. (Janet clarified this after the meeting. Initially she reported that players could not bring their own push carts or remote control, battery operated carts. However, personal push carts are acceptable.)
- Caddies from the course will be available for hire.

Motion was made with a 2<sup>nd</sup> to increase 2026 championship registration fee to \$300. Motion passed.

8. New Business

Entry fee for Championship 2026

- Motion was made with a 2<sup>nd</sup> to increase 2027 registration entry fee at Bellingham (2025 Seniors) to \$210 and no breakfast will be provided. Motion passed.

Subcommittee created to review Rules of Competition and clarify language around required handicap/index for tournaments

- Michelle will lead a subcommittee of Jane Harris, Beth Chew, Cat Felker and Carol Sohn to create new and/or more consistent documentation regarding indexes, increases in registration fees and other rules. Trustees suggested using the same % on fee increases for both championships. Subcommittee will report at either Fall 2025 meeting or next July and ask for a vote.
- **Discussion on Minimum/Maximum yardage for Championship and changes to Index for Championships**

Current Language, ~~Proposed Language removal~~, **Change**

All contestants must have an approved USGA handicap index. Players must have 10 rounds played and posted in the previous 12 months prior to entry cut-off date. ~~This index is then converted to a handicap for the course where the tournament is being played.~~ Players with handicaps of ~~34.0~~ **32.0** and under at the time of registration shall be eligible for the tournament.

- A motion was made with a 2<sup>nd</sup> to remove the language about converting index to handicap and change the index from 34.0 to 32.0 for the Championship. Motion passed.
- No change to the 40.0 index for the Senior Championship.

Discussion on requiring electronic sign up

- Olympia (2026 Senior Championship) may have difficulty with electronic registration because they currently don't use Golf Genius. Marcia Eaton will check and advise.

Standardizing timing of changing of trustees

- Michelle reminded attendees that it's critical for success to make sure 4-year terms are completed unless there is a real emergency. For example, a term would be from October 2023 to October 2027. Each Spring, the Executive Secretary will notify trustees whose terms are up the following October and let them know they can sign up for another four years or they should start recruiting a new trustee. The new or returning trustee should be identified and the Executive Secretary should be notified by October 1<sup>st</sup>. It was suggested this advisory be added to the rules changes the subcommittee will work on.
